## UKSMarT — Live from London

Support for Maritime Training (SMarT) is the UK Government's primary scheme for developing the next generation of British seafarers. It provides financial support to shipping companies to help cover the cost of training Merchant Navy cadets, including tuition, college phases, and sea-time. By reimbursing a significant portion of eligible training expenses, SMarT makes cadetships more accessible and helps maintain the UK's maritime skills pipeline. Recent Government investment has expanded the programme's capacity, increasing annual cadet intake from around 750 to approximately 1,200 trainees. Running through March 2026, SMarT remains a cornerstone of the UK's strategy to strengthen its maritime workforce and ensure a steady supply of qualified officers for the future.

## **A defining moment — Fueled by tension**

Reflections on the MIAL Maritime Decarbonisation Summit journey and the current state of play

MIAL's 6th Maritime Decarbonisation Summit occurs at a defining moment for global shipping. Uncertainty around the International Maritime Organization's Net-Zero Framework - with any decision on adoption now delayed until late 2026 at the earliest - has paused the assumed trajectory of global shipping regulations supporting the climate transition. Meanwhile, escalating tensions in the Middle East have underscored the vulnerability of global energy supply chains. By contrast, the Summit focuses on a more optimistic pathway: Australian innovation. From clean fuels to digital optimisation and port-energy integration, Australia's maritime sector is demonstrating how practical, economically sustainable, industry-led solutions can accelerate decarbonisation while strengthening supply chain resilience and diversifying fuel sources.

## Professor Tony Haymet — Science at the forefront

MIAL welcomes the Chief Scientist of Australia as keynote speaker. Professor Tony Haymet is one of the world's leading oceanographers and a distinguished science leader whose career spans Australia, the United States, and the global maritime community. An emeritus distinguished professor of oceanography, he has held major research and leadership roles, including Chief of CSIRO Marine and Atmospheric Research and Director and Vice-Chancellor of the Scripps Institution of Oceanography. Professor Haymet has authored more than 170 peer-reviewed papers and co-founded major marine research initiatives and ocean-robotics ventures, strengthening global observing systems and advancing marine innovation. Today, as Australia's Chief Scientist, he continues to shape national and international marine science strategy.
